The application of knowledge derived from nursing, social, and public health sciences for the promotion of health and the prevention of diseases in communities is defined by the American Public Health Association (2013) (1).

Key elements of practice include:

2. Assessment of the state of the population's health based on the holistic and systematic approach.
3. Emphasis on multiple determinants of health.
4. A focus on primary prevention.
5. Intervention strategies at all levels- individual, family, community, and systems that affect their health.

Nurses in public health work in various settings, including community health centers, schools, governmental agencies, etc. Their role involves performing assessments and screenings of the community's health status, planning and implementing health promotion programs, and providing education on healthier living. They reduce the incidence of chronic diseases and empower people and communities to live better lives through preventive care.

They are the ones who are at the frontier to offer systematic health screenings, vaccination, and proper education on healthy lifestyles for all.

They advocate policies and programs that ensure necessary care for the most underserved populations. This is the holistic approach that addresses and mitigates health disparities and better outcomes for vulnerable groups.

For example, in times of public health crises like pandemics or natural disasters, they provide direct care, enforce infection control measures, and disseminate public health information. Their skills play a critical role in the management and mitigation of the impacts of such events on the community. Their role in emergency preparedness and response was demonstrated during the COVID-19 pandemic (3).

Public health nurses collaborate with policymakers to design and implement health policies that benefit the majority of underserved populations.

Education and Training

The education and training of public health nurses are designed to equip them with the skills needed to tackle complex health challenges. Nursing curricula often include courses on epidemiology, community health, and health policy. In regions with significant ethnic diversity, such as Geneva, nursing education incorporates the concept of “super-diversity” to prepare nurses for culturally competent care. This approach ensures that nurses can effectively address the health needs of diverse populations (4).
